## Highlights on FY 2020 rates and fees

Austin City Council approved the Fiscal Year 2019-2020 budget Sept. 10. The \$4.2 billion budget maintains quality services and makes targeted investments in core programs and City infrastructure. As part of the budget process, the City Council also approves the rates and fees customers pay through their City of Austin Utilities bill. Below is some highlighted information on FY 2020 rates and fees.

» Austin City Council approved changes to two Austin Energy pass-through charges. An increase in the Power Supply Adjustment and a decrease in the Regulatory Charge means a typical residential customer using 860 kWh per month will see a 1.5 percent — or \$1.33 — increase in their monthly bill. Pass-through charges collect what the utility actually pays as an expense. The effect for each customer depends on how much energy is used.

- » Austin Resource Recovery customers will see a 65 cent per month increase to their utility bill to offset the cost of solid waste services.
- » The monthly Transportation User Fee—funding street maintenance, repair and other activities necessary for keeping Austin's roadways in good condition—remains unchanged. Residential City of Austin Utilities customers may be eligible for an exemption if the person who is responsible for paying the utility bill meets the criteria of being age 65 or older OR does not own or regularly

use a private motor vehicle.

#### Make it count

The City of Austin and Travis County have launched a Census Outreach Campaign to ensure residents are educated and prepared for the 2020 Census. Every 10 years, the U.S. Census Bureau oversees a national survey to determine population totals and breakdowns by sex, age, race and other factors that guide the allocation of more than \$800 billion in federal funding to programs across the U.S. If Texas residents are undercounted by even 1 percent, the state could lose at least \$300 million per year.

# Don't stretch your extension cord safety

Extension cords are handy and inexpensive, but if used improperly, they can cause electrical shorts, fires and dangerous shocks. Make sure your cords are properly rated, and inspect them for damage. Don't run extension cords under rugs, and don't plug one cord into another. Some older homes in Austin do not have three-prong grounded outlets, but never cut off the grounding pin so it will fit in a two-prong outlet. If you find you're using lots of extension cords, consider adding additional outlets.

### **Wastewater Averaging Begins in November**

November marks the beginning of Austin Water's annual wastewater averaging period. The wastewater averaging period spans three consecutive billing periods beginning in mid-November and ending in mid-March. Check your utility bill or visit austinwater.org to find the dates for your wastewater averaging period.

About Wastewater Averaging
Wastewater averaging is a way for
you to save money. It is calculated
during the winter months when
most residential water goes directly
into the sanitary sewer system
versus being used for outdoor
watering. This measurement

determines the cap on the volume of wastewater you will be billed for each month for the next year. If there is outside watering during the wastewater averaging period, that water volume will also be included in the wastewater average. Avoid this by making sure your irrigation systems are turned off during your wastewater averaging period.

Lower Your Wastewater Costs
You can lower your wastewater
costs for the next year by
conserving water during these
billing periods. To help you conserve
water in the winter months and
lower your wastewater average,
follow these basic water-saving tips:

- » Check your irrigation system for leaks and turn them off during the fall and winter months
- » Fix all leaky faucets and toilets
- » Sign up for the free Dropcountr app and get home water use reports
- » Run your dishwasher and washing machine only with a full load
- » Take shorter showers place a timer in your bathroom
- » When buying new water-using appliances, look for the WaterSense® label
